

Note on the results of the May 2016 survey


- Around 500 questionnaires were delivered to houses, mobile home sites and landowners/developers known to be connected with the Parish during May 2016.
- ➤ 206 completed survey forms were returned an excellent response rate of more than 40%.
- ➤ Of the total 206 respondents, 42 % (86) indicated that they had a second home in the Parish and of these around 10% indicated that they were on the Electoral Register and so entitled to vote in the Parish. A further 6% (13 people) indicated that they had a mobile home here.
- For the purposes of understanding any important differences in views, it was decided to first separate out the response of those who said they viewed the village as their main home, followed by those who said they had a second home (interpreted as a permanent structure). A number of people have owned mobile homes in the Parish for many years but there is little information about the overall level of mobile home *ownership* in the Parish (as opposed to the overall number of mobile homes and caravans) and therefore it is difficult to gauge how representative such a small response might be. For this reason, this small group of respondents was therefore dealt with separately.
- ➤ The graphs which follow summarise results from the quantitative analysis for the second homeowners. They follow the format of the original survey with each graph preceded by the question on which it is based. All bar charts are based on the total number of replies received (ie 86).
- Comparable quantitative results for all respondents and respondents who have their main home in the village are presented in separate reports.
- Free text responses, presenting respondents own comments and suggestions are combined into a further individual report.
















2-2 What do you think of the age mix in Holme-next-the-Sea? (Please tick all that apply)




Section 3 Housing




3-2 What do you think is the right scale for future housing development? (Please tick one box in each line)




3-3 What kind of housing do you think is needed in the future? (Please tick one box in each line)




3-4 Thinking about the current choice of homes in the village, what type of new houses do you think will be needed? (Please tick one box in each line)




3-5 What do you think are the right sizes and heights for any future homes in the village? (Please tick one box in each line)




